The ACMA Harvard Scholarship committee received several outstanding applications for the 2005 ACMA scholarships to attend the Harvard Senior Executives in State and Local Government Program. After much discussion, the scholarships were awarded to Terry Doolittle, Deputy County Manager, Pinal County and George Hoffman, City Manager, Apache Junction.

Phoenix City Manager Receives National Public Service Award

Phoenix City Manager Frank Fairbanks was presented with the National Public Service Award, the highest public service award given for distinction in public service by the American Society for Public Administration and the National Public Academy of Public Administration. Fairbanks was one of four individuals recognized with the award during ASPA's

national conference in early April.

Fairbanks was recognized for his work in developing e-government, achieving an AAA excise tax revenue bond rating from Standard and Poors and his membership on local business and community boards.

In 2001, Fairbanks received ICMA's Award of Excellence for his outstanding contribution to professional management. At the 2004 ACMA Winter Conference, Frank was honored with the John J. DeBolske Professional Excellence Award. This award recognizes the highest level of excellence among Arizona local government professionals who have made significant and lasting contributions to their communities, the profession of local government management, and ACMA.

more seasoned managers. The sessions in Track 1 include: What Managers Look for in an Assistant and Diving in Head First: Tales from 1st Time Managers. Track 2 will be offered concurrently and will include a session on preparing for retirement followed by a session on what to do if you find yourself in danger of being in-transition.

Growth issues will be the focus of the conference on Thursday morning. The committee plans to invite an economist and a representative from the Maricopa Association of Governments to open the conference with a discussion of financial trends and projections for the future growth of Arizona. This will be followed by a session on impact fees and fiscal growth analysis. For lunch on Thursday, the committee is hoping to secure ASU President Michael Crow to talk about Arizona's future from a demographics standpoint and his vision for the universities. After lunch two breakout sessions will be offered: sustainable growth and public/private partnerships. Members will have the opportunity to attend both sessions, they will each repeat once. Due to very low attendance at the closing lunch on Friday last summer, the conference

planning committee has decided to offer one session on Friday morning and end the conference at 10:30am. The session will focus on career management. The committee is inviting representatives from professional recruiting firms to discuss the type of career progression they look for when reviewing applications.

ACMA Associates' Committee and Glendale Offer Tour of the City's Sports and Entertainment Corridor



ASU and the League of Arizona Cities and Towns are offering the eighth annual orientation program for newly elected municipal officials Friday, June 10 and Saturday, June 11 at the ASU Downtown Center in Phoenix.

Where are you originally from?

I was born in Marshall, Michigan and moved to Arizona (age 12) in 1970.

Why did you decide to pursue a career in local government?

After graduation from ASU, I decided to live in Arizona the remainder of my life. I had two job offers, an auditor position with the Arizona Auditor General, the other involved moving to Bloomington, Illinois. In 1986, Pinal County recruited me for an internal auditor position. Several promotions later, I'm still here.

What do you like most about your job?

No two days are the same. I like to improve processes and build organizations. These opportunities are continually presenting themselves in local government.

What areas of local government interest you most?

Currently, the American Judicial System in Counties; Superior Court Judges, County Attorney, Public Defender, Contractual Attorneys, Clerk of the Superior Court, Adult and Juvenile Probation, Adult and Juvenile Detention. I am amazed that the process works as well as it does. Great opportunities exist (and are in the works) to improve the individual systems in the judicial process.

The Internet Joke

Some of your buddies have created a "share the humor" e-mail list. It brightens your day to read some of the jokes that you receive, and you look forward to your daily humor. Today, when you turn on your computer you see there's a file waiting for you to open. When you open the file, you are stunned to see a photograph of a naked woman in a parody of a popular advertisement. What do you do?

Option #1

You delete the file and pray that you will never see a message like that one again.

Option #2

You contact the sender, making it clear that you do not want to receive mail like that again.

Option #3

You file a complaint with the human resources director.

Option #4

After you stop laughing, you forward the file to a couple of staff who you think will enjoy it.

Commentary: The worst choice here is Option #4, to forward this joke to others

who you think may enjoy the humor. Sharing an explicit image with others in the work place could open up the organization to a charge of a hostile work environment. Tenet 12 of the ICMA Code of Ethics reminds us that we should respect public time and resources. Using the local government's computer to share explicit images with others is improper. E-mails are subject to public records requests so anything that you communicate on the computer could well appear on the front page of the local newspaper.

The most ethical choice is Option #2 as you are taking action to stop unwelcome e-mails.

Promoting an Ethical Culture

Promoting an ethical culture is a key leadership responsibility. Equity, transparency, honor, integrity, commitment, and stewardship are standards for excellence in democratic local governance. ICMA promotes ethical conduct through its Code of Ethics, training for local governments, publications on ethics issues, technical assistance, and advice to members.
